V. Approval of Treasurers Report and Proposed Budget

VI. New business

- a) Power Point Presentation Mayor David Rice and his staff: Roman Gastesi-County Administrator, Kevin Wilson-County Engineer, and Jim Callahan-County Fire Chief distributed informational booklets and presented information on county programs, budget issues, and contacting officials with code enforcement issues. A Q&A followed. Roman Gastesi urged residents to contact his office for any violations. Dave Williamson requested an electronic copy of this PPP and a complete list of county contact phone numbers from Mayor Rice.
- b) Sewer Update Roger presented updates on the progress of all phases. He is currently investigating solutions to the exposed pipes along the bridges. Jim Callahan will advise DKPOA when the new fire hydrants will go live.
- c) Beautification Jerry presented updates of the progress of the plantings at the lift stations. All plantings are native and will require no watering after established. A rendering of the four island signs were presented to replace decaying street signs. The county has installed street signs making the wooden signs unnecessary. He welcomes suggestions on other green areas to improve with native plants.
- d) Membership cards & website Brian Lancaster, Editor of our DKPOA newsletter and Facebook Page, distributed membership cards to paid members. Anyone not receiving a card can send application and fee to JoAnn. He also presented improvements to the new webpage and how to navigate the more user friendly site. A Q&A session followed. Those experiencing difficulties logging on may see Brian after the meeting to confirm contact information.

- e) Security Tom Neville asked county representatives about the tardiness of camera installation. Kevin Wilson explained that Comcast was having issues with the subcontractor but trenching will begin this Tuesday. Kevin will follow up with DKPOA. Tom invited the manager of Keys Security to answer residents questions. He supplied cards with a phone number and encouraged residents to call him or the Sheriff's office for any questions or concerns.
- f) Presentations JoAnn was presented with a gift of appreciation of her service as Treasurer. Jon Shebel (not present) also received a gift for his service as VP.
- g) Announcements Robin Neville will have another CPR class this Saturday, 2/23/13 from 9am-1pm. You must contact her for more information. A minimum attendance is required to hold class.
