# Our DKPOA Membership

- 663 Total Properties in Duck Key
- 456 homes and 207 lots on the Islands
- Monroe County now owns 89 lots
- DKPOA had 208 paid memberships in 2017
  - 177 home and 31 lot owners
  - 2018 129 paid membership as of 1/27/18
- Property info provided by 12/14/2017 Monroe County Property Appraiser 2016 Membership was 184 homes and 19 lots (203 total)

#### **DKPOA Treasurer's report**

- ▶ 2017 Annual donations @ \$200 per home and \$100 per lot plus additional gifts and interest income
  - ▶ \$43,450 in Total Revenue
- 2017 Annual expenses for Beautification, Maintenance and Capital Projects
  - ▶ \$36,865 in Total Expense
- Y/E 2017 current cash assets
  - ▶ \$47,487 in checking and savings accts.
- ▶ When comparing to 2016 FY 2017 Revenue increased by \$20,009 while Expenses only increased \$780. Irma delayed additional spend.

#### President's report on progress in 2017

- Landscaping maintenance of gardens, lift stations performed throughout the year
- ► Island-wide clean-up day
- Then Irma happened...
- Welcome gardens and street signs restored after the hurricane
- New 'Idle Speed No Wake' buoys installed in Tom's Harbor
- Numerous meetings and discussions held with the County officials on illegal rentals, post Irma clean-up and other services to Duck Key residents
- Obtained County approval for maintenance dredging where sea grass present
- Provided input on new bridge plans
- Joined with Duck Key Community Benefit
- Welcome baskets for new neighbors
- ▶ ID cards (with discounts) for members
- Maintaining website and newsletter with events of interest to our membership

#### What is changing as a result of DKCB?

- ▶ Boards combined. Single insurance and annual filing expense
- Duck Key Community Benefit, Inc is the new legal entity but retained the DKPOA name
- 501c3 corp. EIN 47-3292711
- Contributions considered charitable (CPA advice on individual impact of new tax laws highly recommended)
- Members may contribute to the DKCB and/or the DKPOA. DKCB-directed contributions will go towards maintenance dredging. DKPOA-directed contributions will go towards beautification and other community services.
- Funding, banking and reporting for dredging will remain separate from all other projects
- Effective date Jan 1, 2018

#### 2018 goals DKPOA and DKCB

- Beautification focus on recovery from Irma
  - Organize two major volunteer storm clean-up days
  - Replant and improve ROWs to repair storm damage with help from County
  - Work with County to address fire and vermin problems on unimproved lots
  - Continue to maintain existing welcome and lift station gardens
  - ▶ Develop a plan to park trailers, RVs on designated county lots
- Dredging:
  - Complete permitting process and raise \$220,000 to fund the dredging operation
  - ▶ Re-survey. Go to contract and execute phase 1- all canals
- Other key work:
  - ► Work with County on Bridge replacement plans
  - Consider organizing the Duck Key community to obtain more say on services, the look and feel of our Island, and on how our taxes are spent

# 2018 DKCB Budget - Dredging

- ▶ Dredging project will cost \$350,000 to complete
- Expended \$46,400 project to date (2014-2017)
- ► Current account balance \$133,286
- ► Require \$220,000 in new contributions from concerned residents and friends of DK to finish the job.
- ► Irma may impact funding availability
- Approval of dredging will be handled in a separate meeting of dredging sponsors
