2018 DKPOA Treasurer's Report

- 2018 Annual donations @ \$200 per home and \$100 per lot plus additional gifts and interest income
 - \$59,286 in Total Revenue
- 2018 Annual expenses for Beautification, Welcome and Capital Projects
 - ► \$84,320 in Total Expense (\$75059 was beautification expense)
- 2018 Year End current cash assets

▶ \$47,703 in checking and savings accts.

- When comparing to 2017 FY 2018 Revenue increased by \$15,833 while Expenses increased \$47,454 Irma delayed spend in 2017.

2019 goals DKPOA and DKCB

- Beautification
 - Organize a clean-up day March 2, 2019
 - Continue to plant trees along the ROW
 - Work with County to address fire and vermin problems on unimproved lots
 - Continue to maintain existing welcome and lift station gardens
 - > Develop a plan to park trailers, RVs on designated county lots
- Dredging:
 - Raise the remaining \$67,102 to fully fund the dredging operation
 - Execute the dredging project in Q1
- Other key work:
 - Work with County on Bridge replacement plans
 - Develop plans for repairs to the south and east breakwater
 - Consider organizing the Duck Key community to obtain more say on services, the look and feel of our Island, and on how our taxes are spent



Duck Key Canal Maintenance Dredging Project

- Five areas have been permitted for maintenance dredging: Both the west and east entrances of the canal along West Seaview Circle; the elbow at the end of Vista Lane; the west entrance to the interior canal along East Seaview Drive, and the hump at the midpoint canal near 248 West Seaview Drive.
- We have selected LPS Utilities to perform the work. Mr. Tom Merryman, the owner of the company, is a long time Duck Key resident and has offered terms that are very competitive and attractive. Website https://www.lpsutilities-inc.com/
- The cost of the dredging will the \$150,000 and will include the removal of the spoils from Duck Key. The cost of mitigating damage to sea grass, imposed by the U.S. Dept. of Army Engineers, will be \$157,000.

2019 DKCB Dredging Project Funding

- Total Funds Raised to Date \$297,812 from 55 generous donors THANK YOU!
- Raised \$112,850 Dec 1 to Jan 24 THANK YOU!
- Expended \$56,914 to date (2014-2018 for surveys, consultants and permits)
- Current account balance \$240,898
- Dredging project will cost \$308,000 to complete
- Require \$67,102 in additional new contributions from residents and friends of DK to finish the job.
- Contractor terms allow 3 year to pay

What changed as a result of DKCB?

- One New Board, Single insurance and annual filing expense
- Duck Key Community Benefit, Inc is the new legal entity but retained the DKPOA name
- ▶ 501c3 corp. EIN 47-3292711
- Contributions considered charitable (CPA advice on individual impact of new tax laws highly recommended)
- Members may contribute to the DKCB and/or the DKPOA. DKCB-directed contributions will go towards maintenance dredging. DKPOA-directed contributions will go towards beautification and other community services.
- Funding, banking and reporting for dredging will remain separate from all other projects
- Effective date Jan 1, 2018
